

**PRESBYTERY OF GENESEE VALLEY

Covenant Agreement for Stated Supply Pastors

In order to set forth clearly the terms of appointment for Stated Supply Service between the Presbytery of Genesee Valley and the Rev. _____ concurrence with the Session of _____ the following Covenant is agreed upon:

1. That the Rev. _____ will begin Stated Supply Service on _____ and will be accountable to the church session and the Presbytery of Genesee Valley (through the Committee on Ministry) during the period of this Covenant agreement.

2. The Stated Supply Pastor, the Rev. _____ agrees to provide pastoral leadership _____ full-time _____ part-time (% time _____)

The Stated Supply Pastor will be responsible for the following:

- _____ Preaching and leading the worship life of the church;
- _____ Officiating at baptisms, weddings, and funerals as requested;
- _____ Leading membership classes, other Christian Education programs and any other services mutually agreed upon: _____
- _____ Visiting the sick and shut-ins and counseling members as requested;
- _____ Attending Presbytery meetings, appropriate meetings of committees and making reports;
- _____ Other duties (specify): _____

3. The local church will support and cooperate with the Stated Supply Pastor in every way and will assume responsibility for:

- _____ Attending worship services and meetings;
- _____ Supporting the pastor in the church's ministry to the community;
- _____ Providing clerical assistance as needed.

4. Responsibilities to the Presbytery and to the Presbyterian heritage:

- a. The pastor is expected to attend presbytery meetings.
- b. The pastor will affirm, abide by and support the ordination questions asked of installed clergy.
- c. The pastor will agree to support the theological guidelines stated in the *Book of Confessions*, including the Reformed position on the sacraments.

5. The Terms of this Covenant shall be:

6. This agreement is for a period of _____ months commencing on _____. It will be reviewed annually two months prior to the expiration of the contract by the COM in conversation with the Session and the Stated Supply Pastor. This Covenant may be terminated only by the Presbytery of Genesee Valley, ordinarily with thirty days notice. The Stated Supply Pastor, the Session or the Presbytery may initiate the termination process.

7. The Stated Supply Pastor may not be considered for this installed position except in concurrence with the COM and by $\frac{3}{4}$ vote of the presbytery.
